

JSTS MINUTES OF NOVEMBER 20, 2006 MEETING

Meeting called to order At Brielle Cyclery by President Steve Karger at 7:30pm

Ride Report:

OLD BUSINESS

- **Elections** - Steve announced that this was the first time that he remembers that we are having an election. He printed up ballots, and said that there were no provision for absentee ballots, but that can be taken up in the future. Candidates will be given 5 minute each to state their goals for the club. After the candidates spoke, the election was held.
